## Please note:

Memberships are required for all persons that want to use the club's facilities so that Wilsonian Sailing Club can demonstrate to the RYA and the club's insurers that we have accepted as provisional members the persons above.

This form entitles those persons listed to be provisional members up to the date set as expired so that they can use the club's facilities and club boats (restrictions apply) when the club is officially open and with a CDO present.

Where this form accompanies a specific event (E.g., Sailing Week or Junior Week), there may be additional rules in place around membership obligations and requirements. Please refer to the events documentation for more details.

If no date is set, the expiry is for the day issued only with a maximum duration for expiry as 1 month unless approval has been sought by the General Committee. To continue using the facilities after expiry, the online form must be completed so memberships can be approved.

## Declaration - I understand that my provisional membership:

- is only active once payment has been received and signed off by a club officer or CDO.
- does not allow me to vote or attend any official general meetings of the club.
- can include monohull dinghies up to 5.5m in length and with a Portsmouth Yardstick not exceeding 1382.
- may not include a dinghy space if one is not available.
- excludes me to bring other dinghies to the club or move an existing dinghy without approval.
- requires me to securely tie-down all dinghies to its trolley and ground (where ground tie-downs exist).
- requires me to attach a label to my trolley(s) and trailer(s) with dinghy class, sail number, and my name.
- requires me to hold and maintain adequate third-party liability for all dinghies sailed or stored at the club.
- may require club officials to move my dinghies and trailers where access or work is required.
- excludes the storage of trailers unless prior approval has been received by the General Committee.
- includes that I am responsible for the seaworthiness of all dinghies on my membership whilst afloat.
- includes assistance from safety boats for persons only when they are officially launched for club events.
- should have class association membership for race results to be recorded for open events.
- should comply with sailing instructions published and to sign-on and off for all racing at the race box.
- excludes any responsibility from the club for loss or damage to dinghies or personal property.
- includes my responsibility for the juniors on my membership but can designate other adult members via loco-parentis.
- excludes the club from being expected to exercise supervision or control to juniors on my membership.
- can only be approved once per year unless approved or extended by the General Committee.
- excludes the right to be assigned a club key.
- requires all those persons on this form to abide by the club's rules and byelaws.
- allows for photos and videos to be taken and used by the clubs for any and all marketing purposes.
